- I understand the following information regarding my **Wittenberg University Student Loan (WUSL)**:
Wittenberg University is the Lender of this loan. **The loan is managed by the Student Accounts Office, not Financial Aid.**
A Wittenberg University Student Loan (WUSL) is an entirely different loan from a Wittenberg Federal Perkins Loan (PERK), William D. Ford Federal Direct Loan, Federal Stafford Loan(s), or any other student loan for which I become obligated.
- I understand I am obligated to repay my loan even if I do not complete the program, I am unable to obtain employment, or I am otherwise dissatisfied with my education or other services received.
- I must repay my loan(s) with all accrued interest.
- I have a maximum of 10 years to repay my loan (unless my loans are specified differently on the repayment schedule).
- I may prepay all or part of my loan without penalty.
- The minimum monthly payment for my loan is \$30. Monthly payments can be more depending on the amount borrowed. Repayment will begin following a 6-month grace period.
- The interest rate for my loan is 6%. Interest begins 30 days before the first payment is due.
- Effective July 23, 1992, all new loans and advances are reported to credit bureau organizations.
- I must notify **ACS** or **Wittenberg University's Student Accounts Office**, in writing, within 10 days, if I: change my name, change my address, change my graduation date, transfer to another school, enroll for less than half time, or withdraw from school.
- If I do not qualify for a "student" deferment, and I am unable to make payments on my loan, I may request in writing to Wittenberg University, forbearance on my loan. (You will be notified if you qualify for a forbearance.)
- Wittenberg University Student Loans** are private loans and are not eligible for consolidation with Federal Consolidation Loan Programs. The amount of the Wittenberg Loan (WUSL) will be considered in the calculation of the payment on the consolidation but the Wittenberg Institutional Loan will still need to be paid by borrower.
- If I fail to repay my student loan, I will be considered in default and the following may result: (1) It will be reported to the credit bureau and have a negative effect on my credit rating. (2) The entire unpaid amount of my loan, including interest and late fees, may become due and payable immediately. (3) I may be ineligible to receive any benefits from Wittenberg University including transcripts and readmittance.
